I understand and agree that the Released Parties may not be held liable or responsible in any way for any injury, death, or other damages to me, my family, estate, heirs or assigns on account of injury or resulting in death that may occur as a result of my participation in Flight Training, or as the result of the negligence or otherwise of any party, including the Released Parties, whether passive or active.
