GENERAL WAIVER AND RELEASE OF LIABILITY

For the purpose of this Waiver and Release of Liability, "**Released Parties**" shall refer to **Monterey Bay Aviation Inc.** and their respective instructors, employees, officers, agents, contractors, and assigns. Also for the purpose of this Waiver and Release of Liability, "**Flight Training**" shall refer to piloting aircraft, flying in aircraft, flight instruction, aircraft rental, aircraft operations, ramp operations, and any associated activities involved with these activities.

I, (name) _____, hereby affirm that I am aware that flying and activities associated with flying have inherent and unforeseeable risks, which may result in serious injury or death. I understand and agree that the Released Parties may not be held liable or responsible in any way for any injury, death, or other damages to me, my family, estate, heirs or assigns on account of injury or resulting in death that may occur as a result of my participation in Flight Training, or as the result of the negligence or otherwise of any party, including the Released Parties, whether passive or active.

In consideration of being allowed to participate in Flight Training, I hereby personally assume all risks of Flight Training, whether foreseen or unforeseen, that may befall me while I am participating in these activities, including risk of bodily injury, death or property damage. I further release, exempt and hold harmless the Released Parties from any claim or lawsuit by me, my family, estate, heirs, or assigns, arising from my participation in Flight Training including both claims arising during any course of training or after I receive my pilot certificate(s).

I acknowledge and understand that Flight Training is physically demanding and that I must seek the ongoing care of a licensed and authorized aviation medical examiner as required, and that I will not hold Released Parties responsible for events resulting from my physical condition, limitations, or incapacitation.
